Dear 5 Star Dealers:

It is now time to send in your invoices and claim your rebate. In order to do so, please follow the steps below. The rebate form must be filled out in its entirety to assure your rebate is processed correctly:

1. Submit your Invoices**

Make clear copies of your distributor invoices showing product purchased, quantity and price. Items that qualify are all HullGard, Big B, Supergard and Survivor fenders ONLY (economy fenders do not qualify). All invoices must be dated prior to August 31, 2010. Attach the invoices** to this completed rebate form and send directly to Taylor Made Products via the fax number above or by mail to the address above.**

REBATE RULES

1. Copies of distributor invoices** **must be clearly readable**. If not, they are disallowed.
2. Rebate will not be in effect if the after rebate unit net cost is lower than Taylor published distributor cost.
3. You must purchase products from an established authorized Taylor Made Products distributor.
4. All rebate claims must be submitted by August 31st, 2010.
5. The rebate voucher is good only towards the purchase of additional Taylor Made Products.

Actual invoice copies are not always required. In special cases, some distributors will print recap statements for their dealers. These recap statements will be acceptable if all pertinent information is listed including item number, quantity, purchase price and invoice number. Packing slips or bills of lading are not valid as proof of purchase. The **PART NUMBER AND PURCHASE PRICE must be clearly readable.

3. Collect your Rebate (Use the Rebate Voucher)

When your request for rebate has been verified, Taylor Made Products will send you a rebate voucher, which you can submit to your authorized Taylor Made Products distributor to purchase additional items. (Rebates must be redeemed by expiration date on voucher.)
